## ORDINANCE NUMBER //O./

## AN ORDINANCE RELATING TO THE REAPPORTIONMENT AND REDISTRICTING OF THE MAGISTERIAL DISTRICTS OF GRAYSON COUNTY

WHEREAS, pursuant to KRS 67.045 (4) the Fiscal Court is required to initiate reapportionment proceedings in May of the first year following the decennial census of the United States; and

WHEREAS, pursuant to KRS 67.045 (5) the Grayson Fiscal Court having advertised the reapportionment in accordance with KRS 424 in *The Record* on May 19, 2011; and

WHEREAS, pursuant to KRS 67.045 (5), on the 20<sup>th</sup> day of May, 2011, the Grayson County Fiscal Court appointed Dennie Buckles, Margie Whobrey, Tom Goff and County Clerk Sherry Weedman to serve on the Reapportionment Committee; and

WHEREAS, the Reapportionment Committee submitted their report to the Fiscal Court on July 19<sup>th</sup>, 2011 and the Fiscal Court having reviewed and considered same; and

**WHEREAS**, the Reapportionment Committee having determined each Magisterial District shall have the following voting precincts in conformity with KRS 67.045:

**District #1:** All of East Leitchfield, East A Leitchfield and Clarkson (with an estimated population of 4073) and more particularly described as follows:

Begin at the intersection of Salt River Rd. and Kiper Rd., going south to city limits then west to intersection of Mill St. and North Main St.; follow North Main St. south crossing Western KY Pkwy to city limits; follow city limits east out to Bloomington Rd.; continuing east to intersection of Hwy 1214 and Hwy 88; follow center of Hwy 88 south to Sims Rd.; follow Sims Rd. southeast to end of road then Northeast to junction of Hwy 1214 and Pearl Oak Rd.; follow Pearl Oak Rd to first branch and follow this branch Southeast to Rock Creek; follow Rock Creek to Rock Creek Rd.; go north on Rock Creek Rd. to Hwy 224; go east in the center of Hwy. 224 to Crow Hollow Rd.; go north in center of Crow Hollow Rd to Western KY Pkwy; go east to Clifty Creek; follow Clifty Creek northwest to intersection of Beaver Dam Creek; follow Beaver Dam Creek to Kiper Rd.; follow Kiper Rd. back to intersection with Salt River Rd.

**District #2:** All of Short Creek, Caneyville, Spring Lick, Falls of Rough and Yeaman (with an estimated population of 4183) and more particularly described as follows:

Begin at intersection of Hopewell Rd. and Green Decker Rd. going southeast along road to first branch; follow branch south to Watershed Lake; go along north side of Watershed Rd. cross Hwy 62 and continue south along Dunns Creek to Western KY Pkwy.; continue South just east of Wilson Church Rd. to Caney Creek Rd.; follow Caney Creek Rd. west to Hwy 185; cross Hwy 185 following center of Hudson Rd. to Farris Coates Rd.; go northwest to Log Cabin Lane; follow this road to end and connect at first branch; then west to Odle Rd.; follow Odle Rd. south to county line; follow county line west to Cromwell Rd.; continue following county line north to Olaton Rd. then east to Little Clifty Creek; follow Little Clifty Creek south to branch near end of Stones Chapel Rd.; follow this branch southwest to intersection of Hwy 631 and Stones Chapel Rd.; follow center of Hwy 631 south to Hwy 54; follow center of Hwy 54 southeast to Sinks Rd.; follow this road 1000 feet; then go south to intersection of Hopewell Rd. and Hornback Rd.; goes west back to intersection of Hopewell Rd and Green Decker Rd.

**District #3:** All of Millwood, West A Leitchfield and North Leitchfield (with an estimated population of 4245) and more particularly described as follows:

From Little Clifty Creek go east along county line to Hwy 737; follow center of Hwy 737 south to city limits; follow city limits north and east crossing Hwy 259 and then south and east to Salt River Rd.; follow center of Salt River Rd. south to Mill St.; go west in center of Mill St. to intersection of North Main Street and Mulberry Street; Run west in center of Mulberry St. to ICRR; follow ICRR southwest to Sunbeam Rd.; follow center of Sunbeam Rd. northwest to intersection of western city limits just south of Boston Hill Rd.; follow city limits south, then west to Hwy 62; follow center of Hwy 62 west to Quarry Rd.; follows Quarry Rd. west to Quarry; from this point go west crossing Ray Priddy Rd. just south of Wilson Lane, west to junction of Little Clifty Creek crossing Hwy 2193; go from this point south on a line that is west of Black Rock Dr. crossing Hwy 62 and on due south to Western KY Pkwy staying west of Black Rock Rd.; follow Western KY Pkwy to Langdon Rd.; follow center of Langdon Rd. southeast to Caney Creek Rd.; follow center of Caney Creek Rd. west to point just east of Wilson Church Rd. junction line; go north crossing Western KY Pkwy; follow Dunn Creek north just east of Watershed Rd.; following this line just east of road so as to exclude all houses on this road; go north to North Fork and on to the road that connects with Green Decker Rd.; follow this road northwest to Hopewell Rd.; follow center of Hopewell Rd. east to Junction with Hornback Rd.; go north to a point on Sinks Rd about 1000 feet west of Hwy 54; follow center of Sinks Rd Northeast to Hwy 54; follow Hwy 54 west to Hwy 631; follow Hwy 631 north to

Stones Chapel Rd.; from this point line goes northeast to branch that goes directly into Little Clifty Creek; follow Little Clifty Creek north to county line.

**District #4:** All of Horntown, Big Clifty and North A Leitchfield (with an estimated population of 4257) and more particularly described as follows:

Begin at city limits and Hwy 737; follow center of Hwy 737 north to county line; follow county line east along northern boundary crossing Hwy 62; then follow south to county line to Nosey Creek; follow Nosey Creek west to Bell Rd.; follow Bell Rd. to Hwy 224, crossing Hwy 224 to Oak Grove Rd.; follow this road west to second branch; follow this branch south and west to Rock Creek Rd.; follow center of Rock Creek Rd. north to Hwy 224; follow center of Hwy 224 east to Crow Hollow Rd.; follow center of Crow Hollow Rd. to Western KY Pkwy; follow Western KY Pkwy east to Clifty Creek; follow Clifty Creek west to Beaver Dam Creek; follow creek south to Kiper Rd.; follow center of Kiper Rd. southeast to Salt River Rd.; follow center of Salt River Rd. southwest to city limits; follow city limits back to Hwy 737.

**District #5:** All of Rock Creek, Anneta, Millerstown and South A Leitchfield (with an estimated population of 4273) and more particularly described as follows:

Begin at intersection of old city limits and Hwy 62 just east of McDonald Rd.; go south to Western KY Pkwy crossing parkway south to McClure Fork so that all houses on McDonald Rd. are excluded; follow McClure Fork south to Bear Creek; follow Bear Creek south to county line; follow east county line to Pine Hurst Bay; follow county line north to Nosey Creek; follow Nosey Creek west to end of Bell Rd.; follow Bell Rd. west crossing Hwy 224 to Oak Grove Rd. at first branch of Rock Creek; follow west to intersection of Downs School Rd. and Rock Creek Rd.; go west following branch to intersection of Sims Rd. and Logsdon Cemetery Rd.; go northwest to intersection of Hwy 1214 and Peonia Rd.; go due west following old city limits to the intersection with Hwy 62.

**District #6:** All of West Leitchfield, South Leitchfield, Arlington, Shrewsbury and Ready (with an estimated population of 4415) and more particularly described as follows:

Begin at intersection of North Main St. and Mulberry St. and follow center of Mulberry St. west to ICRR; follow ICRR southwest to Sunbeam Rd.; follow center of Sunbeam Rd. north to city limits just past Walnut Hill; follow city limits southwest and south to intersection of Hwy 62; follow Hwy 62 south to Black Rock Dr.; follow Black Rock Dr. to Black Rock Rd. on to Langdon Rd.; follow Langdon Rd. southeast to Caney Creek Rd.; follow center of Caney Creek Rd. west to Hwy 185 crossing Hwy 185 to Hudson Rd.; follow Hudson Rd. to Farris Coates Rd.; follow Farris Coates Rd. to branch to Odle Rd. to county line; follow county line east to Saltsman Branch; follow branch north to Bear Creek to McClure Fork; follow fork north to McDonald Rd. crossing Western KY Pkwy and continuing to city limits; follow old city limits northeast to intersection of

Hwy 259 and Western KY Pkwy; go north on Hwy 259 to intersection of North Main St. and Mulberry St.

## NOW, THEREFORE, BE IT ORDAINED BY THE FISCAL COURT OF GRAYSON COUNTY, KENTUCKY AS FOLLOWS:

That each Magisterial District of Grayson County shall have the following voting precincts, as specifically described herein below, in each district and shall constitute the reapportioned magisterial districts in conformity with KRS 67.045 and the 2010 decennial census of the United States:

**District #1:** All of East Leitchfield, East A Leitchfield and Clarkson (with an estimated population of 4073) and more particularly described as follows:

Begin at the intersection of Salt River Rd. and Kiper Rd., going south to city limits then west to intersection of Mill St. and North Main St.; follow North Main St. south crossing Western KY Pkwy to city limits; follow city limits east out to Bloomington Rd.; continuing east to intersection of Hwy 1214 and Hwy 88; follow center of Hwy 88 south to Sims Rd.; follow Sims Rd. southeast to end of road then Northeast to junction of Hwy 1214 and Pearl Oak Rd.; follow Pearl Oak Rd to first branch and follow this branch Southeast to Rock Creek; follow Rock Creek to Rock Creek Rd.; go north on Rock Creek Rd. to Hwy 224; go east in the center of Hwy. 224 to Crow Hollow Rd.; go north in center of Crow Hollow Rd to Western KY Pkwy; go east to Clifty Creek; follow Clifty Creek northwest to intersection of Beaver Dam Creek; follow Beaver Dam Creek to Kiper Rd.; follow Kiper Rd. back to intersection with Salt River Rd.

District #2: All of Short Creek, Caneyville, Spring Lick, Falls of Rough and Yeaman (with an estimated population of 4183) and more particularly described as follows:

Begin at intersection of Hopewell Rd. and Green Decker Rd. going southeast along road to first branch; follow branch south to Watershed Lake; go along north side of Watershed Rd. cross Hwy 62 and continue south along Dunns Creek to Western KY Pkwy.; continue South just east of Wilson Church Rd. to Caney Creek Rd.; follow Caney Creek Rd. west to Hwy 185; cross Hwy 185 following center of Hudson Rd. to Farris Coates Rd.; go northwest to Log Cabin Lane; follow this road to end and connect at first branch; then west to Odle Rd.; follow Odle Rd. south to county line; follow county line west to Cromwell Rd.; continue following county line north to Olaton Rd. then east to Little Clifty Creek; follow Little Clifty Creek south to branch near end of Stones Chapel Rd.; follow this branch southwest to intersection of Hwy 631 and Stones Chapel Rd.; follow center of Hwy 631 south to Hwy 54; follow center of Hwy 54 southeast to Sinks Rd.; follow this road 1000 feet; then go south to intersection of Hopewell Rd. and Hornback Rd.; goes west back to intersection of Hopewell Rd and Green Decker Rd.

**District #3:** All of Millwood, West A Leitchfield and North Leitchfield (with an estimated population of 4245) and more particularly described as follows:

From Little Clifty Creek go east along county line to Hwy 737; follow center of Hwy 737 south to city limits; follow city limits north and east crossing Hwy 259 and then south and east to Salt River Rd.; follow center of Salt River Rd. south to Mill St.; go west in center of Mill St. to intersection of North Main Street and Mulberry Street; Run west in center of Mulberry St. to ICRR; follow ICRR southwest to Sunbeam Rd.; follow center of Sunbeam Rd. northwest to intersection of western city limits just south of Boston Hill Rd.; follow city limits south, then west to Hwy 62; follow center of Hwy 62 west to Quarry Rd.; follows Quarry Rd. west to Quarry; from this point go west crossing Ray Priddy Rd. just south of Wilson Lane, west to junction of Little Clifty Creek crossing Hwy 2193; go from this point south on a line that is west of Black Rock Dr. crossing Hwy 62 and on due south to Western KY Pkwy staying west of Black Rock Rd.; follow Western KY Pkwy to Langdon Rd.; follow center of Langdon Rd. southeast to Caney Creek Rd.; follow center of Caney Creek Rd. west to point just east of Wilson Church Rd. junction line; go north crossing Western KY Pkwy; follow Dunn Creek north just east of Watershed Rd.; following this line just east of road so as to exclude all houses on this road; go north to North Fork and on to the road that connects with Green Decker Rd.; follow this road northwest to Hopewell Rd.; follow center of Hopewell Rd. east to Junction with Hornback Rd.; go north to a point on Sinks Rd about 1000 feet west of Hwy 54; follow center of Sinks Rd Northeast to Hwy 54; follow Hwy 54 west to Hwy 631; follow Hwy 631 north to Stones Chapel Rd.; from this point line goes northeast to branch that goes directly into Little Clifty Creek; follow Little Clifty Creek north to county line.

**District #4:** All of Horntown, Big Clifty and North A Leitchfield (with an estimated population of 4257) and more particularly described as follows:

Begin at city limits and Hwy 737; follow center of Hwy 737 north to county line; follow county line east along northern boundary crossing Hwy 62; then follow south to county line to Nosey Creek; follow Nosey Creek west to Bell Rd.; follow Bell Rd. to Hwy 224, crossing Hwy 224 to Oak Grove Rd.; follow this road west to second branch; follow this branch south and west to Rock Creek Rd.; follow center of Rock Creek Rd. north to Hwy 224; follow center of Hwy 224 east to Crow Hollow Rd.; follow center of Crow Hollow Rd. to Western KY Pkwy; follow Western KY Pkwy east to Clifty Creek; follow Clifty Creek west to Beaver Dam Creek; follow center of Salt River Rd.; follow center of Salt River Rd. southwest to city limits; follow city limits back to Hwy 737.

**District #5:** All of Rock Creek, Anneta, Millerstown and South A Leitchfield (with an estimated population of 4273) and more particularly described as follows:

Begin at intersection of old city limits and Hwy 62 just east of McDonald Rd.; go south to Western KY Pkwy crossing parkway south to McClure Fork so that all houses on McDonald Rd. are excluded; follow McClure Fork south to Bear Creek; follow Bear Creek south to county line; follow east county line to Pine Hurst Bay; follow county line north to Nosey Creek; follow Nosey Creek west to end of Bell Rd.; follow Bell Rd. west crossing Hwy 224 to Oak Grove Rd. at first branch of Rock Creek; follow west to intersection of Downs School Rd. and Rock Creek Rd.; go west following branch to intersection of Sims Rd. and Logsdon Cemetery Rd.; go northwest to intersection of Hwy 1214 and Peonia Rd.; go due west following old city limits to the intersection with Hwy 62.

**District #6:** All of West Leitchfield, South Leitchfield, Arlington, Shrewsbury and Ready (with an estimated population of 4415) and more particularly described as follows:

Begin at intersection of North Main St. and Mulberry St. and follow center of Mulberry St. west to ICRR; follow ICRR southwest to Sunbeam Rd.; follow center of Sunbeam Rd. north to city limits just past Walnut Hill; follow city limits southwest and south to intersection of Hwy 62; follow Hwy 62 south to Black Rock Dr.; follow Black Rock Dr. to Black Rock Rd. on to Langdon Rd.; follow Langdon Rd. southeast to Caney Creek Rd.; follow center of Caney Creek Rd. west to Hwy 185 crossing Hwy 185 to Hudson Rd.; follow Hudson Rd. to Farris Coates Rd.; follow Farris Coates Rd. to branch to Odle Rd. to county line; follow county line east to Saltsman Branch; follow branch north to Bear Creek to McClure Fork; follow fork north to McDonald Rd. crossing Western KY Pkwy and continuing to city limits; follow old city limits northeast to intersection of Hwy 259 and Western KY Pkwy; go north on Hwy 259 to intersection of North Main St. and Mulberry St.

The full text of the report of the Reapportionment Committee and its legal description of boundaries of each Magisterial District can be found of record in the Grayson County Fiscal Court Minutes dated July 19, 2011 and of record in Fiscal Court Orders Book UU at Page 1, records of the Grayson County Clerk's Office. A map outlining the Magisterial Districts consistent with the legal descriptions of the Reapportionment Committee is attached hereto and made a part hereof and labeled Exhibit A.

Pursuant to the provisions of KRS 67.045(8), any registered voter of the county may enforce the provisions of 67.045 within twenty (20) days of the establishment of the districts by the ordinance.
