AN ORDINANCE AMENDING THE ORDINANCE
RELATING TO THE ESTABLISHMENT OF
AN ENHANCED 911 (E-911) EMERGENCY TELEPHONE SERVICE
WITHIN GRAYSON COUNTY, KENTUCKY

WHEREAS, the Fiscal Court of the County of Grayson of the Commonwealth of Kentucky, has previously adopted on the 25th day of August, 1992, an Ordinance Relating to the Establishment of an Enhanced 911 (E-911) Emergency Telephone Service Within Grayson County, Kentucky; and

WHEREAS, the Enhanced 911 Governing Board established by said ordinance, presently consists of Sixteen (16) members with the Grayson County Judge/Executive serving as Chairman; and

WHEREAS, the majority of the Sixteen (16) members presently on the Enhanced 911 Governing Board also represent an organization that utilizes the Dispatch Center; and

WHEREAS, the present makeup of the Enhanced 911 Governing Board is prone to create conflicts and lack of cooperation among Board members; and

WHEREAS, the Fiscal Court of Grayson County feels that it would be in the best interest of the citizens of Grayson County if the present makeup of the Enhanced 911 Governing Board was changed;

NOW, THEREFORE,

BE IT ORDAINED BY THE FISCAL COURT OF THE COUNTY OF GRAYSON, COMMONWEALTH OF KENTUCKY;

That Section IV (b.) of an ordinance relating to the establishment of an Enhanced 911 (E-911) Emergency Telephone Service within Grayson County, Kentucky be and hereby is deleted and there is substituted therefore an Amendment to read as follows:

Section IV: "Enhanced 911" Governing Board

(b.) The board shall consist of the following persons:

- (A) The Grayson County Judge/Executive or his designee who shall serve as Chairman
- (B) The Chief of Police of the City of Leitchfield or his designee
- (C) The Grayson County Sheriff or his designee
- (D) The Grayson County Jailor or his designee
- (E) One member, who shall be appointed by the Grayson County Judge/Executive, with the approval of the Grayson County Fiscal and shall serve for a term of three years.

This Ordinance amending the Ordinance Relating to the Establishment of an Enhanced 911 (E-911) Emergency Telephone Service with Grayson County, Kentucky shall

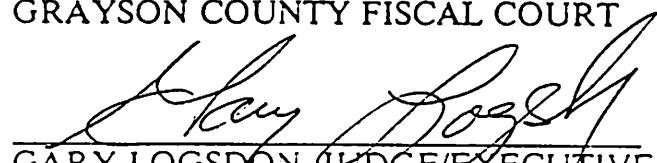
become effective immediately upon passage and publication.

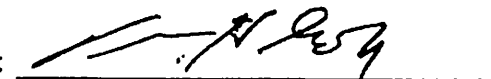
