## ORDINANCE NUMBER 150. 2

## ORDINANCE ESTABLISHING THE GRAYSON COUNTY CEMETERY BOARD

WHEREAS, the Grayson County Fiscal Court recognizes the need to restore and maintain non-profit cemeteries throughout the county; and

WHEREAS, there is a need within Grayson County to restore and maintain non-profit cemeteries; and

WHEREAS, K.R.S. 67.680 authorizes the creation of a county cemetery board that may apply to the department of local government for grants to restore and maintain non-profit cemeteries that do not receive perpetual care funds pursuant to K.R.S. 67.952; and

WHEREAS, the said Fiscal Court of Grayson County has determined that there exists a need for the formation and establishment of a cemetery board to govern the restoration and maintenance of non-profit cemeteries that do not receive perpetual care funds pursuant to K.R.S. 67.952;

NOW, THEREFORE, IT IS HEREBY ORDAINED BY THE FISCAL COURT OF GRAYSON COUNTY, COMMONWEALTH OF KENTUCKY, as follows:

- 1. That pursuant to K.R.S. 67.680 the Fiscal Court of Grayson County, Kentucky does hereby create, establish and form a county cemetery board to have all duties, powers, authorities and responsibilities as enumerated in chapter 67 of the Kentucky Revised Statutes.
- 2. That the name of the Cemetery Board shall be and hereby is the Grayson County Cemetery Board.
- 3. That said Board shall meet three (3) times annually at a place provided by the Fiscal Court and shall have five (5) volunteer members with no more than three (3) representing the same political party. Members shall be appointed by the County Judge/Executive with approval by the Fiscal Court,

they shall have lived in the county for at least one (1) year prior to appointment, and they shall have demonstrated an interest in cemetery preservation, genealogy, local history, or a related area.

4. The appointment term for each cemetery board member shall be for a period of four (4) years except for initial appointment terms. Initial appointment terms shall be as follows:

Two (2) members appointed for a one (1) year term;

Two (2) members appointed for a two (2) year term; and

One (1) member appointed for a three (3) year term
