ORDINANCE NUMBER 220.100

ORDINANCE ASSESSING ADDITIONAL FEES AND COSTS IN GRAYSON CIRCUIT AND DISTRICT COURTS

WHEREAS, KRS 23A.220, KRS 24A.185, and KRS 64.091 allow County Fiscal Courts to impose by Ordinance additional costs relating to District Courts, Circuit Courts, and the County Sheriff's Office.

NOW, THEREFORE, IT IS HEREBY ORDAINED BY THE FISCAL COURT OF GRAYSON COUNTY, COMMONWEALTH OF KENTUCKY, as follows:

ARTICLE I: GENERAL PROVISIONS

Section 1. SHORT TITLE: This Ordinance shall be known as the Additional Fees and Costs Ordinance and shall be cited herein as "this Ordinance".

<u>Section 2.</u> PURPOSE AND POLICY: For the purpose of paying expenses for the courthouse, bonds relating to it, and administration thereof in Circuit Court and District Court.

The Grayson County Fiscal Court hereby establishes an increase in the following fees and costs in the following matters:

- A. The Fiscal Court shall assess additional fees and costs, for the purpose of paying expenses for the courthouse, bonds relating to it, and administration thereof in Circuit Court and District Court.
 - (i) In civil cases, a fee of twenty-five (\$25) dollars shall be added to filing fees.
 - (ii) In criminal cases, a fee of twenty-five (\$25) dollars shall be added to the Court costs that the defendant is required to pay.
 - (iii) In civil cases that are appealed from Circuit Court to the Court of Appeals, a fee of twenty-five (\$25) dollars shall be added to the filing fees.
 - (iv) In all traffic offenses, a fee of ten (\$10) dollars shall be added to the Court costs for each traffic offense.
 - (v) In probate cases, a filing fee of ten (\$10) dollars shall be added to each filing fee.
 - (vi) In misdemeanor cases, a cost of twenty (\$20) dollars shall be added to the Court costs.
 - (vii) In small claims cases, a fee of ten (\$10) dollars shall be added to all filing fees.
 - (viii) In civil cases, a fee of ten (\$10) dollars shall be added to all filing fees.

- B. The Fiscal Court shall assess additional fees on subpoena and civil summons served by the Grayson County Sheriff's Department, for the purpose of paying expenses for the courthouse, bonds relating to it, and administration thereof. The fees shall be as follows:
 - (i) In addition to the fees normally charged for the service of a subpoena, the person requesting service shall be charged a fee of ten (\$10) dollars.
 - (ii) In addition to the fees normally charged for the services of a civil summons, the person requesting service shall be charged a fee of ten (\$10) dollars.

ARTICLE II: SEVERABILITY

In the event that one or more of the provisions of this Ordinance shall be subsequently ruled invalid by a Court of Competent Jurisdiction of the Commonwealth, all remaining provisions shall remain in full force and effect.

ARTICLE III: REPEAL OF PRIOR ORDINANCES

Any Ordinance provision thereof, which is in direct conflict with this Ordinance, shall be repealed effective upon the date on which this Ordinance becomes operative.
