COMMONWEALTH OF KENTUCKY GRAYSON COUNTY FISCAL COURT ORDINANCE NUMBER 150.2

AN ORDINANCE ESTABLISHING A THIRD AMENDMENT TO THE ORDINANCE RELATING TO THE ESTABLISHMENT OF THE GRAYSON COUNTY TOURIST COMMISSION AND TRANSIENT ROOM TAX

WHEREAS, the fiscal court of the County of Grayson of the Commonwealth of Kentucky, has previously adopted on the 25th day of August, 1992, an Ordinance Relating to the Establishment of the Grayson County Tourist Commission and Transient Room Tax; and

WHEREAS, said Ordinance requires organizations doing business as motor courts, motels, hotels, inns or alike or similar accommodation businesses to submit to the Fiscal Court taxes collected through the transient room tax imposed by said ordinance on a monthly basis; and

WHEREAS, the Fiscal Court has an interest in enforcing the collection of said taxes,

NOW, THEREFORE, BE IT ORDAINED BY THE FISCAL COURT OF THE COUNTY OF GRAYSON, COMMONWEALTH OF KENTUCKY;

That the Section Seven of an ordinance relating to the establishment of the Grayson County Tourist Commission and Transient Room Tax be and hereby is amended for the third time to read as follows, with deleted words indicated by a single line drawn through them and added words indicated by brackets for and aft:

SECTION FIVE: To provide funds for the operation of the Commission, there is imposed a transient room tax of three (3%) percent on the rent of every occupancy of a suite, room or rooms similar persons, groups or organizations doing business as motor courts, motels, hotels, inns or like or similar accommodation businesses and that transient room tax shall apply to [the] rent or to occupancy of a room in a motor court, motel, hotel, inn or like

[, cabins, lodgings, campsites, or other accommodations charged by any hotel, motel, inn, tourist camp, tourist cabin, campgrounds, recreational vehicle parks, or any other place in which accommodations are regularly furnished to transients for consideration or by any person that facilitates the rental of the accommodations by brokering, coordinating, or in any other way arranging for the for the rental of the accommodations.] or similar accommodation businesses for a consecutive period or thirty (30) days or less in Grayson County, Kentucky.

This Ordinance amending the Ordinance relating to the Establishment of the Grayson County Tourist Commission and Transient Room Tax becomes effective immediately upon passage and publication.
