ORDINANCE NO. _____

ORDINANCE RELATING TO THE ESTABLISHMENT OF A HOUSING NUMBERING SYSTEM IN GRAYSON COUNTY, KENTUCKY

WHEREAS, KRS 67.083 and other applicable law grants the Fiscal court authority to provide for the public safety, health and welfare of the citizens and properties located in Grayson County, Kentucky; and

WHEREAS, Grayson County is now served by the Sheriff's Department, Fire Department and rescue personnel whose services can be accommodated by homeowners' posting their properties with visible house numbers; and

WHEREAS, the Grayson County Enhanced 911 Board does now assign house numbers; and

WHEREAS, the Fiscal Court has determined a need to require homeowners to properly identify their properties by posting assigned house numbers.

NOW, THEREFORE, BE IT ORDAINED BY THE FISCAL COURT OF GRAYSON COUNTY, COMMONWEALTH OF KENTUCKY, that:



All residential property owners and owners of commercial and industrial property containing an active business building shall obtain their assigned house number from the Grayson County Enhanced 911 Board. All residential property owners and owners of commercial or industrial property where there is an active business building shall post the assigned numbers on both their mailboxes and buildings or residence in such fashion that the numbers shall be readily visible from the public street or road providing access to the property. Numbers shall not be less than three (3) inches in height and shall be made of durable and clearly visible material.

Section 2:

The homeowner shall use arabic numerals to post his property. Roman numerals, script numerals or other types of numerals shall not be used for the house numbering system required by this Ordinance.

Section 3:

Any homeowner who has not posted his property according to the terms of this Ordinance within ninety (90) days of the adoption and publication of this Ordinance shall be fined not less than ten dollars (\$10.00), nor more than one hundred dollars (\$100.00). Each day of violation shall be deemed to be a separate offense.

Section 4:

This Ordinance shall become effective upon its passage and publication according

to law.
