COMMONWEALTH OF KENTUCKY GRAYSON COUNTY FISCAL COURT ORDINANCE NO. 220.72

AN ORDINANCE AUTHORIZING AND DIRECTING THE COLLECTION OF ADDITIONAL COURT COSTS AND FEES FOR THE PURPOSE OF COSTS RELEATED TO COURT FACILITIES

WHEREAS, Grayson County is authorized by the laws of the Commonwealth of Kentucky to enact an ordinance establishing additional court costs and fees for the purpose of paying costs related to court facilities; and,

WHEREAS, a current ordinance enacted for the same purpose was based on the 2000 Judicial Branch Budget Bill which expires June 30, 2002; and,

WHEREAS, it is the intention of the Fiscal Court by this ordinance to continue the collection of additional court costs and fees to pay the expenses related to court facilities;

THEREFORE, IT IS HEREBY ORDERED by the Fiscal Court of Grayson County,
Kentucky that additional fees and costs in Grayson Circuit and District Courts in civil and
criminal cases are assessed as follows:

- A. 1. In Circuit civil cases a fee of \$25.00 shall be added to the filing fees;
 - In Circuit criminal cases a cost of \$25.00 shall be added to the court costs that a defendant is required to pay;
 - In civil cases that are appealed from Circuit Court to the Court of Appeals a fee of \$25.00 shall be added to the filing fee;
 - 4. In all traffic cases a fee of \$10.00 shall be added to court costs for each traffic offense;
 - 5. In probate cases a fee of \$10.00 shall be added to each filing fee;
 - 6. In misdemeanor cases a cost of \$20.00 shall be added to the court costs:
 - 7. In small claims a fee of \$10.00 shall be added to all filing fees;

- 8. In District civil cases a fee of \$10.00 shall be added to all filing fees;
- 9. In addition to the fees normally charged for the service of a subpoena, the person requesting service shall pay an additional fee of \$10.00;
- 10. In addition to the fees normally charged for the service of a civil summons, the person requesting service shall pay an additional fee of \$10.00.
- B. This ordinance is being adopted for the expense purpose of continuing to impose additional costs and fees relating to District Court, Circuit Court and the Sheriff's Office. The fees collected pursuant to this ordinance shall be paid to the Grayson County Fiscal Court as required by law and the Fiscal Court shall expend said funds as required by law.
- C. This ordinance shall be in full force and effect upon final adoption and publication as required by law.
